Re: Issuance of Revisions to Multiple Academic Personnel Manual (APM) Policies to Remove Gendered Language

Dear Colleagues:

I am formally issuing multiple revised policies of the Academic Personnel Manual (APM) as listed in Attachment 1. The revisions to the APM policies listed on Attachment 1 are purely technical revisions to remove gendered language and to correct minor grammatical errors. In addition, these policies have been reformatted to improve online accessibility.

Please note that in order to maintain policy clarity and minimize the possibility of misinterpretation of policy, we intentionally avoided using the historically plural pronouns "they," "them," and "their" in these revisions. Some APM policies that contain gendered language, including policies in the APM -700 series and APM - 240, and APM - 246, are being revised separately, and APM - 025 has already been revised to remove gendered language. In addition, some older appendices to certain policies of the APM have not been revised to remove gendered language because they are historical documents that were incorporated into the APM and changing the language would not be appropriate.

The revised policies are effective immediately and may be found online on the <u>Academic Personnel and Programs website.</u>
